debt or demand and costs, as shall exonerate the said James Gilkyson, administrator aforesaid, from any debt or liability on my part, as an heir of said estate.

EDWIN FRAZER.

Where any difficulty presents in distributing the balance of an estate to heirs, the administrator can apply to the Orphans' Court, through an attorney, for the appointment of an auditor to make distribution.

#### RELEASE FROM HEIRS.

An administrator should, before paying out the funds of an estate to heirs, take a release from each one, duly acknowledged before a person having authority, and have the same recorded in the office for recording deeds, etc.

#### STATEMENT OF ACCOUNTS.

Immediately after the expiration of one year from the date of letters, an administrator is required to file a statement of his accounts in the Register's office, charging himself with the amount of the inventory of personal effects and all moneys received, and crediting himself with all moneys paid, giving dates, which shall be examined by and { sworn or } to before the Register, { affirmed } who will have the same advertised for four weeks immediately preceding the term of court.

An administrator is not required to pay shares to heirs until his statement of accounts has been duly confirmed by the Orphan's Court.

*Note.*—In the city of Philadelphia and county of Montgomery all administrator's accounts are referred to an auditor by the Orphans' Court before confirmation.
